MANDATORY / PRELIMINARY REQUIREMENTS/CONDITIONS

All firms applying for the **AGPO** reserved categories (Youth, Women and Persons with Disabilities Owned Enterprises) must submit and fulfill the following requirements for verification of their eligibility: -

- iii. AGPO Registered firm may participate in the <u>open categories</u> but will be required to fulfill requirements under the open categories level.
- iv. For Provision of Services please provide proof of 3 completed contracts.

a) Category B and C

Demonstration of sufficient technical/operational capability and relevant experience: Experience in details of similar assignments/supplies recently undertaken. Attach a list of 3 copies of reference letters/ award letters or signed contracts

b) Category B/015- Repair and Maintenance of Motor Vehicle

Firms must provide proof of existence for the past three years and

c) Category B/017, Air Ticketing Services

Firms must provide proof of membership with **IATA & KATA**. The firms should demonstrate that they have 24 hour dedicated personnel/call line to cater for emergency requirements.

d) Category B/019 and B/033

Valid CAK or ICT Authority Accreditation certificate relevant to the category of application

e) Category B/023- Provision of Consultancy Services.

Consultancy Services - The bidders Must indicate specialized area of consultancy e.g. Integrity Surveys, Monitoring & Evaluation, Governance audit, Development and review of Strategic Planning, trainings, employee satisfaction survey, policy development and review, competency baseline survey, Energy Audit, Environmental Audit, Feasibility study.

Consultancy for Legal services

The legal firm will be should to perform the following,

- i. Certified copy of current practicing certificates for all partners and associates;
- ii. Senior Partner(s) must have a minimum experience of 10 years
- iii. Evidence of the firm's Professional Insurance Indemnity of at least KES.1,000,000.00 but capable of being reviewed depending on the brief at hand.
- iv. A signed statement by the senior counsel that the bidder is not debarred from participating in public procurement.

f) Category B/024- Provision of Valuation Services

Certificate of Registration by Valuers Registration Board for Registration of Valuation services

g) Category B/034 Provision of Comprehensive cleaning and Sanitary Bin Services

- i. Firms must provide valid compliance certificates from NHIF and NSSF and proof of compliance with minimum wage requirements under Kenya Labor law.
- ii. Firms must provide waste disposal and transportation license from National Environment Management Authority (NEMA)

h) Category B/035 -Provision of Hotel Accommodation and Conference Facility

- i. Valid and current accreditation certificate for hospitality sector or membership of a recognized or accredited organization
- The Hotels should state their geographical locations and be (4) star rated and above in Mombasa, Malindi, Machakos, Nairobi, Embu, Nyeri, Nanyuki, Naivasha, Nakuru, Eldoret, Kakamega and Kisumu. (Hotels in other towns other than the ones mentioned can apply and be considered based on provision of quality standards)
- iii. Anti-FGM Board Secretariat may undertake an inspection visit to the hotels that have applied with view to conducting due diligence on the facilities and establish whether they meet the quality standards.

i) Category C3 Minor building, repair, maintenance, plumbing and electrical works

Firms must provide valid registration certificate from NCA.
